Let us meditate on the reflection of water. O Lord of Ocean Blue, give me higher intellect. And let the God of Water illuminate my mind.

Sri Varuna Bhagavan Temple is located at Serayampalayam Road, Neelambur, Coimbatore. This is one of the few temples built during the 20th century. The temple is believed to have been constructed at a time when the people in this area suffered greatly due to drought and famine.

Lord Varuna is one of the important Vedic deities described elaborately in the hymns of the Rig Veda. The four Vedas

describe him as a deity who created heaven, earth, and air. He is considered to be omnipresent and omniscient. Varuna means "he who covers." He is also the controller of rivers, streams, lakes, and oceans. He is also known as the "God of Oceans". That is the reason why fishermen offer prayers and perform to this Lord before going fishing.

Legend
Lord Varuna is believed to be one of the most ancient deities in Hinduism and is regarded as a universal monarch. In Rigveda, Varuna is thought to be the keeper of the moral law, one who disciplines.

Lord Varuna is the son of Sage Kashyapa and one of the twelve gods regarded as Adityas. In Hindu scriptures, he is regarded as the father of the Vedic sage Vasishtha. Varuna is considered to be the lord of the waters and was assigned the job of controlling the clouds



and rains. Thus, he is revered as the King of Waters and manages the rivers, seas, oceans, and all the water bodies. It is also believed that worshipping the deity shields us from thunder and lightning.

According to one of the mythologies, Varuna, being the ruler of the Asuras, was adopted

and converted into a Deva after constituting the primordial cosmos, levied by Indra after he overthrows Vritra.

In the Yajurveda, Varuna is referred to as the patron god of physicians, one who can come with a thousand remedies. His abilities and expertise, as well as the connection with

his 'all-comprehensive wisdom', are cited in the Atharvaveda.

Deities
The main deity of the temple is Varuna Bhagavan. There are also other shrines for Siddhi Vinayaga, Sri Bala Murugan, Kasi Viswanathar, Srinivasa Perumal, Bairavar, Dakshinamurthy, Hanuman, and Navagrahas.

Pujas
The temple performs the usual pujas every day. Special pujas are done for Bairavar on Mondays, which attracts a huge crowd of devotees.

Festivals
The temple celebrates all the days of Navarathri in a grand and colorful manner. Tamil New Year Day and Deepavali Day are also celebrated with special pujas to the deity.

Benefits
Devotees carry water in pots for abhishekam to the deity, to be devoid of all their worries and enjoy prosperity. Worshipping the Lord can help cure many diseases. The deity is also said to help people who are afraid of water.

Timings
The temple performs the usual pujas every day. Special pujas are done for Bairavar on Mondays, which attracts a huge crowd of devotees.
